






Structure of the IEE Bioenergy key action



18 solid biomass projects (Funding: € 17.5 m)

14 biogas projects (Funding: € 16 m)


6 liquid biofuels projects (Funding: € 5.2 m)







Barrier: Underdeveloped biomass supply









Barrier: Unfavourable policy framework




