1 Introduction

The aim of the training was to offer other possibilities for the public land owners on how to manage their land by developing plantations of short rotation crops.

The main target group invited to the training was public land owners. However interest from the target audience was not enough high and other interested parties were invited.

The training took place on 30th of May, 2016 in Madona, Latvia. The venue was chosen in order to efficiently disseminate project ideas and results within the Vidzeme region. The first training for public land owners was organised in Valmiera.

All together 23 participants took part at the training, showing their interest in the topic.

The agenda included following topics:

- Introduction to SRC project;
- What is short rotation coppice? SRC in Vidzeme planning region. Existing situation.
 Barriers. Options. Practical examples;
- Afforestation and planting of woody plantations regulatory framework;
- SRC on not used agricultural land;
- SRC seedlings and service;
- · Good practice cases. SRC plantations with different species;
- Sustainability criteria;
- Analysis of the unexploited potential for SRC in Vidzeme planning region;
- Strategy and implementation concept for new SRC plantations in Vidzeme planning region;
- Subsidies for SRC;
- Evaluation of land and SRC potential for new plantations;
- Synergies of SRC with other land uses.

Based on the feedback gained after the first training, higher attention was paid to the practical examples and economic issues. Examples on evaluation of economics for new SRC plantations were presented and discussed.

2 Involved stakeholders

As already described before, the main target audience was public land owners. However, due to not sufficient interest from the target audience other interested parties were addressed and invited.

At the end the training was attended by representatives from municipalities and industry, farmers, forest owners, managers of public and private forests, suppliers of SRC planting materials, Rural Development Service, educational institutions and consultants.

3 Results

Full day training gather different participants with different background and covered topics which are significant for anyone who is about to develop short rotation plantations.

Discussions and questions followed after each of the presentation thus showing that the participants had a real interest in the topic.

Aivars Žandeckis from Ekodoma introduced auditorium with the *SRCplus* project and possibilities how the participants could be involved in *SRCplus*. After the introduction Dagnija Lazdiņa (Silava) gave a summary on what are short rotation crops and what is the existing situation in Vidzeme planning region, giving some practical examples too. Regulatory framework regarding the afforestation and SRC plantation was described by Irēna Aleksejuka – representative from the LVM Seeds & Plants (part of the JSC Latvia's State Forests). In the same time Irēna was presenting activities and experience of JSC Latvia's State Forests regarding the SRC. Training continued with representatives from two companies (Lāsma Apsīte, Ekomark and Reinis Silups, SalixEnergi Baltic) providing SRC planting materials and full service including plantation, management and harvesting of SRC. Both were describing good practice examples and main problems experienced.

Dainis Zuika, a farmer also focused on forestry and SRC plantations, was presenting his personal SRC related experience. Dagnija Lazdiņa gave a presentation on sustainability criteria of SRC, followed by three presentations on the research under the WP6 – presentations on Analysis of the unexploited potential in Vidzeme planning region (VPR), given by Kristaps Makovskis from Silava, Strategy for SRC plantations and Implementation concept for SRC in VPR presented by Aivars Žandeckis. Representative from the Rural Support Service Una Berģe shared the latest information regarding the available subsidies and support schemes. Examples on land evaluation and detailed economic analysis for SRC plantations was presented by Pēteris Lakovskis and Alberts Auziņš (both from the Institute of agroresources and economics). The training was concluded by Dagnija Lazdiņa showing the synergies with other types of land use.

The training was fruitful, gathering experts in the field as well as those who want to learn about the advantages and possibilities of development of short rotation crops.




